The Centre has revised the guidelines for uplinking and downlinking of Television channels in India. In the new guidelines, rules and procedures have been simplified to promote ease of doing business. Companies would be allowed to uplink foreign channels from Indian teleports which would create employment opportunities and make India a teleport hub for other countries. Furthermore, a new provision has been added to encourage TV channels to broadcast content related to public service and national interests including agriculture, women empowerment and education.

India's first national repository for life science data, the Indian Biological Data Center (IBDC), has been inaugurated at Faridabad, Haryana. As per the BIOTECH-PRIDE guidelines of the Government of India, IBDC is mandated to archive all life science data generated from publicly-funded research in India. Supported by the Department of Biotechnology (DBT), IBDC been established at the Regional Centre of Biotechnology (RCB), Faridabad, with a data disaster recovery site at National Informatics Centre (NIC), Bhubaneshwar. The repository has a data storage capacity of about 4 petabytes and houses the 'Brahm' High-Performance Computing (HPC) facility.

India Joins Mangrove Alliance for Climate (MAC) at COP27

India has joined the Mangrove Alliance for Climate, MAC, at the 27th session of the Conference of the Parties (COP27) at Sharm el-Sheikh in Egypt. After joining the alliance, India called for the integration of mangroves conservation with the reducing emissions from deforestation and forest degradation (REDD) programmes for carbon sequestering. MAC is an intergovernmental alliance that seeks to expand and hasten the progress towards conservation and restoration of mangrove ecosystems. India is among the first five countries to join the MAC, including Australia, Japan, Spain, and Sri Lanka



China Offers USD 9 Billion Bailout Package to Pakistan

China has offered a USD 9 billion bailout package to Pakistan and pledged more support for the cash-strapped nation, saying that it has done its "utmost" to stabilise the financial situation of its all-weather ally and will continue to do so. Pakistan owes international debt of around USD 10.7 billion from wealthy western nation under Paris Club. The Paris Club is a group of officials from major creditor nations whose role is to find coordinated and sustainable solutions to the payment difficulties experienced by debtor countries. According to the International Monetary Fund (IMF), Pakistan's total non-Paris Club bilateral debt currently stands at about USD 27 billion, of which Chinese debt is about USD 23 billion.
